 One Semester in JNTUH and three Semesters in KFRU Leading to Masters degree in KFRU.

I.ADMISSION INFORMATION

1. GENERAL

1. International MastersProgramme(IMP) is designed for the advantage of the student community through which students can acquireMasterof Science degree fromboth JNTUH and Reutlingen University Knowledge Foundation (KFRU), Germany in twoyears. The special arrangement increases the face value of the degree and makes it free from local recognition hurdles which students usually face at the time of employment or Ph.D. Studies in India after pursuing studies in Foreign Universities. Hence the students can promote with a domicile degree from JNTUH in India. The students can promote in Europe with a degree from KFRU. This program prepares the students to compete in the labour market in a better way both in India and abroad.

2. Applications for admission into International Masters Programme underIMP will be processed by JNT University, Hyderabad in association with Reutlingen University Knowledge Foundation(KFRU),Germany.

3. There will be no provision for students to discontinue their studies in the middle of

the program and claim an alternative degree.

4. All Admissions are purely provisional, and the University reserves the right to cancel the admission at any stage.

Note: Programme will be offered only when the number of candidates taking admission is more than 50% of the total intake in each specialization.

2. ELIGIBILITY REQUIREMENTS

Candidates satisfying the following requirements shall be eligible for admission for the IMP-2025-26:

- 1. Grades: A first class in the qualifying the examination in B.Tech / B.E (CSE or its allied branches).
- 2. Selection criteria: The selection of candidates will be based on rank obtained in PGECET -2025 rank (qualified rank) / GATE score 2025.
- 3. Candidates should be of Indian Nationality/Persons of Indian Origin (POI)/Overseas Citizens of India (OCI) card holders.

3. STRUCTURE OF INTERNATIONAL MASTERS PROGRAM:

The duration of the IMP will be of 2 years (90 ECTS) which includes education at JNTUH and at KFRU. The participants admitted will undergo Six months of education at JNTUH further 1 ½ year at KFRU which includes master's thesis work under the Joint supervision at KFRU only.

4. FEE STRUCTURE & SCHOLARSHIPS:

English Criteria: KFRU proposes to adopt the English requirement aligning with the national admission requirement of Germany. As per the national admission requirement, the students can meet the English requirement with upper secondary studies with grades issued by the Telangana state board of Intermediate or equivalent with English as the medium of instruction.

Note: The students, who have studied in other languages (medium of instruction other than English) during intermediate education, then the student should demonstrate to meet the English language requirement through an internationally approved English test such as IELTS or TOEFL iBT.

The students should meet the English requirement either by IELTS or TOEFL iBT before seeking admission to studies at KFRU.

- IELTS: an overall mark of 6.5 and no section below 5.5
- TOEFL iBT: Score of 20 (scale 0-30) in written test, total score of 90

5. VISA REQUIREMENTS & ACCOMMODATION:

The students should be able to fund their travel & living expenses for their stay at Germany. Students should be able to show a minimum financial requirement of $\notin 992$ per month for the entire planned study period in Germany. Documentation certifying one's own must be provided at the time for applying visa as per the requirements of the Migration Board.

For 18 Months stay in Germany, the students should show a minimum financial requirement of Approx. €16,812which is approximately ₹16.76 lakhs INR before German Migration Board while applying for VISA (Student Residence Permit). No hostel accommodation will be provided at JNTUH. The average accommodation cost will be around €4,800 /Annum during the study period at KFRU, Germany.

NOTE:-Students are responsible to show the required financial proof to the migration authorities while applying for a student permit (VISA). Either KFRU or JNTUH will not be responsible for the visa rejections caused on the grounds of insufficient financial funds/statements in front of the Migration Board. The Migration Board is an independent agency, and where KFRU or JNTUH cannot influence the decision.

6. INSURANCE:

Indian students under the age 30 pursuing undergraduate or master's programs in Germany are eligible for public (statutory) health insurance through providers like Techniker Krankenkasse (TK), AOK, DAK, and Barmer. For example, TK currently charges a total of around $\pounds 139$ per month (health + long-term care insurance) for students under the age 23 and slightly more for those older. This coverage is comprehensive, and it includes doctor visits, hospitalization, basic dental care, and prescriptions, with direct billing to doctors and hospitals (no upfront payment required) and is widely accepted by German universities and authorities.

7. AFTER STUDIES IN GERMANY:

Students who successfully complete their studies in Germany are eligible to **extend their residence permit for up to 18 months** to seek employment related to their field of study or explore opportunities for self-employment. During this period, graduates can work in any job to support themselves while searching for a suitable position. Once they find employment related to their qualification, they can apply for a longer-term residence permit or an EU Blue Card.
