REMENA- Renewable Energy and Energy Efficiency - Management, Engineering, and Application is an intensive, interdisciplinary double-degree master's from University of Kassel, ideal for professionals aiming to develop technical *and* intercultural expertise in

renewable energy across Germany and the MENA region. It emphasizes hands-on modules, cultural immersion, and academic-industry collaboration.

University of Kassel is situated in Kassel, a city in the central German state of Hesse, Germany.

Jawaharlal Nehru Technological University Hyderabad (JNTUH) is a premier Institute of technical education in India with strong academic and research profile pioneering higher education.

Medium of Instruction is completely in English.

ADMISSION INFORMATION

I. GENERAL INFORMATION

1. **Double Degree Master of Science Programme (DDMSp)** is designed for the advantage of the student community through which students can acquire Master of Science degree from both JNTUH and University of Kassel, Germany in two years. The special arrangement increases the face value of the degree and makes it free from local recognition hurdles which students usually face at the time of employment or Ph.D. Studies in India after pursuing studies in Foreign Universities. Students can pursue opportunities in India with a degree from JNTUH and in Europe with a degree from the University of Kassel. This program prepares students to compete more effectively in the labour market, both in India and abroad.

2. Applications for admission into International Masters Programme under DDMSp will be processed by JNT University Hyderabad in association with University of Kassel, Germany.

3. There will be no provision for students to discontinue their studies in the middle of the program and claim an alternative degree.

4. All Admissions are purely provisional, and the University reserves the right to cancel the admission at any stage.

Note: Program will be offered only when the number of candidates taking admission is more than 50% of the total intake in each specialization.

II. ELIGIBILITY REQUIREMENTS

Candidates satisfying the following requirements shall be eligible for admission for the DDMSp-2026-27:

1. Grades: A first class in the qualifying the examination in B.Tech / B.E (Mechanical, EEE, Chemical, production, Metallurgy, Automobile Engineering, etc).
2. Selection criteria: The selection of candidates will be based on rank obtained in TG PGECET -2026 rank (qualified rank) / GATE score - 2026.
3. Candidates should be of Indian Nationality/Persons of Indian Origin (POI)/Overseas Citizens of India (OCI) card holders.
4. Minimum of 1 year work experience in any relevant field is mandatory.

III. STRUCTURE OF DOUBLE DEGREE MASTER OF SCIENCE PROGRAM:

The duration of the DDMSp will be of 2 years which includes education at JNTUH and at University of Kassel. The participants admitted will undergo six months of education at JNTUH and one and half year at University of Kassel which includes master's thesis work under the Joint supervision at University of Kassel only.

V. MEDIUM OF INSTRUCTION

Medium of Instruction for the students admitted to this course is ENGLISH. University of Kassel proposes to adopt the English requirement aligning with the national admission requirement of Germany. As per the national admission requirement, the students can meet the English requirement with upper secondary studies with grades issued by the Telangana State board of Intermediate or equivalent with English as the medium of instruction.

Note: The students, who have studied in other languages (medium of instruction other than English) during intermediate education, then the student should demonstrate to meet the English language requirement through an internationally approved English test such as IELTS or TOEFL iBT.

The students should meet the English requirement either by IELTS or TOEFL iBT before seeking admission to studies at University of Kassel.

- **IELTS:** an overall score of 6 and no section below 5.5
- **TOEFL iBT:** Score of 20 (scale 0-30) in written test, total score of 90

VI. VISA REQUIREMENTS & ACCOMMODATION:

The students should be able to fund their travel & living expenses for their stay at Germany. Students should be able to show a minimum financial requirement of €992 per month for the entire planned study period in Germany. Documentation certifying one's own must be provided at the time for applying visa as per the requirements of the Migration Board.

For 18 Months stay in Germany, the students should show a minimum financial requirement of Approx. €17,856 which is approximately ₹19.64 lakhs INR to German Migration Board while applying for VISA (Student Residence Permit).

No hostel accommodation will be provided at JNTUH. The average accommodation cost will be around €4,800 /Annum during the study period at University of Kassel, Germany.

NOTE: Students are responsible to show the required financial proof to the migration authorities while applying for a student permit (VISA). Either University of Kassel or JNTUH will not be responsible for the visa rejections caused on the grounds of insufficient financial funds/statements in front of the Migration Board. The Migration Board is an independent agency, and where University of Kassel or JNTUH cannot influence the decision.

VII. INSURANCE

Indian students under the age 30 pursuing undergraduate or master's programs in Germany are eligible for public (statutory) health insurance through providers like Techniker Krankenkasse (TK), AOK, DAK, and Barmer. For example, TK currently charges a total of around **€141 per month** (health + long-term care insurance) for students under the age 30 and slightly more for those older. This coverage is comprehensive, and it includes doctor visits, hospitalization, basic dental care, and prescriptions, with direct billing to doctors and hospitals (no upfront payment required) and is widely accepted by German universities and authorities.

VIII. LIFE AFTER GRADUATION IN GERMANY

Students who successfully complete their studies in Germany are eligible to **extend their residence permit for up to 18 months** to seek employment related to their field of study or explore opportunities for self-employment. During this period, graduates can work in any job to support themselves while searching for a suitable position. Once they find employment related to their qualification, they can apply for a longer-term residence permit or an EU Blue Card.
