#### I.ADMISSION INFORMATION

#### 1. GENERAL

1. Integrated Double Degree Master's Program (IDDMP) is designed for the advantage of the studentcommunity through which students can acquire both B. Tech. & M. Tech degrees from JNTUH and Masterof Science degree from Blekinge Institute of Technology (BTH), Sweden in FIVE years. The special arrangement increases the face value of the degree and makes it free from local recognition hurdles which students usually face at the time of employment or Ph.D. Studies in India after pursuing studies in Foreign Universities. Hence the students can promote with a domicile degree from JNTUH in India. The students can promote in Europe with a degree from BTH. This program prepares the students to compete in the labour market in a betterway both in India and abroad.

2. Applications for admission into Integrated B. Tech & M. Tech/ M. S – Computer Science & Engineering/ Software Engineering/ AI+ML/ Machine Learning, Sensors&Systems under IDDMP will be processed by JNT University, Hyderabad in association with Blekinge Institute of Technology, Sweden.

3. There will be no provision for <u>students to discontinue their studies in the middle of the program and</u> <u>claiman alternative degree.</u>

4. All Admissions are purely provisional, and the University reserves the right to cancel the admission at any stage.

Note: Programme will be offered only when the number of candidates taking admission is more than 50% of the total intake in each specialization.

#### 2.. ELIGIBILITY REQUIREMENTS

Candidates satisfying the following requirements shall be eligible for admission for the IDDMP-2025-26:

- 1. Candidates with Intermediate Education (10+2 patterns) conducted by the T.S./A.P Board of Intermediate Education (BIE)/CBSE/ICSE with Mathematics, Physics, and Chemistry subjects with a minimum of 60% (first class).
- 2. Candidates should be of Indian Nationality/Persons of Indian Origin (POI)/Overseas Citizens of India (OCI) card holders.
- 3. The candidates should have completed 16 years of age by the date of commencement of admissions or on such other date as may be notified by the entrance test committee. There is no upper age limit.

#### 3. STRUCTURE OF INTEGATED DOUBLE DEGREE MASTERS PROGRAM

Theduration of IDDMP is 5 years (10 Semesters) and thestudentsadmittedhavetoundergothefirst 3 ½ years (Sevensemesters) ofmandatoryeducation at JNTUH, Hyderabad and, after obtaining therequired ligibility, theremaining 1½ years (Threesemesters) ofmandatoryeducation at BTH, Sweden.

#### **BTH Merit Scholarships:**

The students are eligible to apply for BTH Merit Scholarship (Tuition fee waivers) for a Tuition fee waiver on existing tuition fees for the international free movers. The selection of BTH scholarship awardees will be doneas per the merit of academic excellence among all the international students. The results of scholarships willbe declared in the month of July (around the commencement of 4-I semester at JNTUH). The scholarships areoffered subject to availability.

A refund of the fee will not be entertained once admission is made. Fee shall be paid at the beginning of each academic year at JNTUH and semester-wise at BTH. There is no concession of fee at JNTUH orstipend/scholarship during their study period at JNTUH.

**English Criteria**: BTH proposes to adopt the English requirement, aligning with Sweden's national admission requirements. As per the national admission requirement, the students can meet the English requirementwithupper secondary studies with grades issued by the Telangana state board of Intermediate or equivalent, with Englishas the medium of instruction.

**Note**: The students, who have studied in other languages (medium of instruction other than English) during intermediate education, then the student should demonstrate to meet the English language requirement through an internationally approved English test such as IELTS or TOEFL iBT. The students should meet the English requirement either by IELTS or TOEFL iBT before seeking admission tostudies at BTH.

- IELTS: an overall mark of 6.5 and no section below 5.5
- TOEFL iBT: Score of 20 (scale 0-30) in written test, total score of 90

### 5. VISA REQUIREMENTS& ACCOMMODATION:

The students should be able to fund their travel & living expenses for their stay at Sweden. Students should be able to show a minimum financial requirement of SEK 10584 (Sweden Kronas) per month for the entire planned study period in Sweden. Documentation certifying one's own must be provided at the time of applyingfor a visa as per the requirements of the Migration Board.

For 18 Months stay in Sweden, the students should show a minimum financial requirement of SEK 190 512 Approx. INR 17.15 Lakhs (As per the present currency exchange rate 1 SEK= 9 INR\*) before Swedish Migration Board while applying for VISA (Student Residence Permit). For further details check www.migrationsverket.se

No hostel accommodation will be provided at JNTUH. The average accommodation cost will be around 58800 SEK/Annum during the study period at BTH, Sweden.

**NOTE**:-Students are responsible to show the required financial proof to the migration authorities while applying for a student permit (VISA). Either BTH or JNTUH will not be responsible for the visa rejections caused on the grounds of insufficient financial funds/statements in front of the Migration Board. The Migration Board is an independent agency, and where BTH or JNTUH cannot influence the decision.

\* Information and currency exchange rates provided are subject to change, The rules decided by the migration board during the year of transition are applicable. Please check the details from **www.migrationsverket.se** for applicable rules and regulations while applying for a residence permit for transition to BTH.

**6. INSURANCE:** The students are fully protected by comprehensiveinsurance provided by BTH. Theinsuranceprovides 24-hour coverage in Sweden. The insurance covers, Medical and Dental Care, Home transport cover, personal Liability Cover, Legal expenses, etc. The insurance (FAS) is provided by

#### 7. AFTER STUDIES IN SWEDEN:

The successfully completed students are eligible to extend their residence permit for one year to seek employment or examine the possibilities of starting their own business as per the regulations of the migration board. For more details: www.migrationsverket.se. Migration policies are subject to change without the involvement of JNTUH and BTH.

#### 8. PLACEMENTS/ CAREER AFTER PROGRAMME

The IDDMP students admitted in the 2025-26 academic year are eligible to participate in campus placements conducted at JNTUH University College of Engineering, Science, and Technology for the academic year 2029-30 only.

**Employment in Sweden**:Swedish universities do not offer campus placements in a similar manner like Indian universities.Instead, they maintain close collaborations with leading companies through education and research. Many students undertake their thesis work or internships within these companies, often leading to employment opportunities after graduation.

Students are encouraged to take initiative, connect with companies directly, and build their own career paths. Many students have successfully secured jobs at top companies like **Ericsson**, **Volvo**, **Scania**, **Sigma**, **and Axis**. The entry-level engineering salaries starting at around SEK 35,000/month (approx. **INR 3.13 lakhs**). Some have also been recruited to prestigious programmes like **Ericsson Global Talent** and the **Volvo Graduate Engineers** *Programme*. *List of some of the students who secured employment in Sweden & abroad is provided in Appendix 1*.

#### 8. HOW TO APPLY

Candidates are required to apply online application and download the Information booklet from the website **www.jntuh.ac.in/https://doa.jntuh.ac.in/**. The duly filled-in application form with one set of enclosures and a registration fee of Rs.2,000/- must be submitted online.

Applications received after the last date of submission including with a fine will not be accepted. The office of the **Directorate of Admissions** is not responsible for the non-receipt or late receipt of applications sent by Post / Courier. Incomplete applications are liable to be summarily rejected.

#### **10. SELECTION CRITERIA**

The selection will be based on ranks obtained in JEE (Mains) -2025 /TG EAPCET-2025 in the order of preference indicated.

30% of seats will be allotted based on the JEE (Mains)-2025 Rank and the other 70% of seats based on TG-EAPCET-2025 Rank.
